An overview of the Integrated Waste Management Strategy and the new waste by-law 2016-144 was given for the benefit of the new members.

5.3 Guest: Reclay StewardEdge - C&D Study

Dave Faris Yousif from Reclay StewardEdge made a presentation to the Task Force in regards to a construction and demolition assessment and consultation plan. Waste audits are to take place in late February to early March 2017. A presentation will come back in May or June to the Task Force with findings and feasibility of implementing such a program.

5.4 Update on Clear Bag Program

The Task Force was advised that early numbers indicate that our recycling volume is up five percent and the amount of waste entering the landfill is down five percent. Staff advises that multi-residential buildings are still being looked at but units with 6 or less apartments are being asked to comply.

5.5 Re-use Centres

Discussion was held in regards to incorporating a Re-use Centre at the Lindsay Ops landfill or other landfill sites as part of the Integrated Waste Management Strategy. Staff noted that an internal review of the Fenelon landfill Re-use Centre operations is currently ongoing. Committee recommends waiting until the review the Fenelon Re-use Centre is complete before further direction is provided for additional Re-use Centres.
