- 4.1 Petition for Drainage Works by Road Authority

Memorandum Regarding Cameron Road Mike Farquhar, Supervisor Technical Services - Engineering & Corporate Assets

Mr. Farquhar provided an overview of the Petition for Drainage Works by Road Authority that was received by the Director of Engineering and Corporate Assets, J. Rojas. He identified that a City drainage easement in the area of Cameron Road (Kawartha Lakes Road 34) required a protected outlet for drainage, and could be incorporated into the petition for the Waite Drain under section 8(4) of the Drainage Act. Mr. Farquhar and Mr. Herlihey responded to questions put forth by the members of the Board.

5.1 Drainage Issues Task Force Update

## **Background:**

At the October 10<sup>th</sup> 2017, Council meeting the following resolution was adopted for the Webster Municipal Drain petition.

#### CR2017-874

**RESOLVED THAT** Report ENG2017-023, **Petition for Drainage Works by Owner – Webster**, be received;

**THAT** Council proceeds with the petition submitted by Alan Webster (Victor Webster Farms Ltd.) for drainage works by owners for Concession 5, Part Lot 11, Geographic Township of Eldon and instruct the City Clerk to proceed with the notices required under Section 5 of the Drainage Act;

**THAT** Council appoints and retains, R. Dobbin Engineering Inc. in accordance with the Drainage Act, as the Engineer of Record, and to proceed with the requirements of a petition drain; and

**THAT** should, R. Dobbin Engineering Inc. not be available, that Council instructs staff to retain an alternate qualified Engineer from the standing list.

#### CARRIED

Since that time the Engineer of Record Michael Gerritis of R. D. Dobbin has held 2 public meetings for the land owners in the drainage shed of the proposed drain. The first meeting was on November 1, 2017. This first meeting was to attention to the land owners in the drainage area of the petition that a petition had been for filed for drainage by Alan Webster and the intent of Council to move forward with this petition under the drainage act. The second meeting was held on June 6, 2018 with the owners in the drainage shed of the petition to review with land owners the draft design and cost schedule. At this meeting it was discussed that any land owners wishing to have direct benefit from the proposed drain should consider signing onto the current petition.

From this meeting and with discussions with Michael Gerritis, Mathew Wechsel (agent for Ella Wechsel) decided it would be beneficial to sign onto the current petition.

The subject area/ land are bounded by Prospect road to the West and CKL road 8 to the north. There are no existing Municipal Drains within the vicinity. The area of the land identified as Concession 5 N ½, Lot 8 and Lot 9 W ½ Lot 10, Geographic Township of Eldon. The land is approximately 100 acres in size.

The draft report which was shown to the land owners in the affected area at the second public meeting has the alignment of the proposed drain going through the Wechsel property. However it was only designed to receive surface water as the Wechsels had not been part of the original petition. By signing onto the petition the depth of the drain through the Wechsel property can now be designed to adequately receive subsurface water.

If approved by Council, R.D Dobbin would make these changing based on the Wechsel petition and would then proceed to Council for the meeting to consider the report. At that meeting there will a last opportunity for anyone to removal or add their names to the petition.


