5.1.4 KLAAC2019-02.5.1.4

Downtown Lindsay Reconstruction - Stakeholders Meeting Collection of Comments

B. Condie advised that the following comments from the Committee were provided to the City's Engineering and Corporate Asset Division for consideration in the design stages of the reconstruction of Downtown Lindsay. In summary some of the key points mentioned included but were not limited to the following:

- that while pavers do meet accessibility requirements there needs to be a commitment to maintain them as per the Integrated Accessibility Standards Regulation as part of the Accessibility for Ontarians with Disabilities Act. Without this commitment the Committee would not be in favour of the use of pavers in the main traffic area;
- Should pavers be utilized there needs to be highly contrasted lines (soldiering) to identify the traffic areas that assist in navigation to those who are legally blind;
- Concern about ground level tree locations presenting a trip hazard, etc.

The City's Engineering and Corporate Assets Division provided a conceptual diagram to illustrate the soldiering that could be used for the pavers to address the concern identified by the Committee.

The Committee expressed their appreciation for the conceptual diagram and recommended a slight change to the placement of the colour soldiering. B. Condie agreed to relay that recommendation to staff.

The Committee asked if the City was going to allocate temporary accessible parking locations during the construction. B. Condie advised that she would also relay that recommendation to staff.

5.2 Public Awareness (Public Education, Employment, Information and Communication)

E. Peeters advised a Working Group Meeting was held on Wednesday, February 13, 2019 and a number of items were discussed, including:

- the Committee's Work Plan
- the Accessibility Event that will be held in partnership with Fleming College in October; and
- the promotion of the Accessibility Awards and the intake of the nomination forms.
