#### 7.4 Tire Collection Update

Staff went over the memorandum outlining the options for tire collection and the issues that have been experienced over the past year. Staff are recommending that Kawartha Lakes stop accepting tires for recycling at the City's landfill sites and direct customers to producer operated collection sites for recycling.

7.5 Main Street Waste Receptacles

Julia brought up the issue of the waste receptacles on the main street of Fenelon Falls. Garbage is often overflowing with people's personal waste filling up the area around the bins.

Julia will be working to remove the circle tops of each of the receptacles and will be asking businesses to adopt the garbage cans that are located in proximity to their locations.

New garbage bins are to be replaced with the street reconstruction therefore this is a temporary solution and there is a need for the City to become involved in design discussions to ensure they are properly managed in the future.

7.6 Roadside Litter

Mike commented on the amount of litter on City roads and is curious if there is a solution and possibly a pilot program that could be implemented. It was suggested that in problem areas potentially a large bin could be placed for people to throw their garbage, or potentially something with a target that would at least capture the materials, rather than them ending up on roadsides.

It was also noted that there is the adopt-a-road program where people can volunteer for a clean up and will be provided all the necessary tools.

This is something that staff have taken note to discuss internally, to come up with a solution.
