## 5.1 Accessibility Officer Update

B. Condie noted that COVID-19 resources for people with disabilities is available on the City Website and can be found under the Living Here link. Congratulations was extended to Parks and Recreation on the public opening of Logie Park in Lindsay noting the many features offering people of various abilities the pleasure of many outdoor recreational opportunities. Wide paved walkways provide access to an accessible playground with rubberized matting and accessible splash pad that is accompanied by accessible washrooms and change areas. B. Condie also expressed congratulations to Lindsay Transit for their success in securing funding from the upper tier Governments that will enhance conventional and specialized transit services.

## 5.2 Public Awareness (Public Education/Employment/Information&Communication)

E. Peeters provided a brief update from the Public Awareness Group. C. Morrissey continued by expressing disappointment about the cancellation of the presentation of the 2020 Accessibility Awards due to COVID-19 noting the desire to proceed with collecting nominations for 2021. B. Condie advised that award nominations can be submitted throughout the year and that the nomination form is available on the City Website. The Awards will be presented at a Council Meeting in 2021. If not in person, virtually. B. Condie also noted that the working group is exploring the opportunity to deliver virtual information sessions addressing Mental Health, Hearing, Sight and other information.

## 5.3 Public Spaces (Parks, Built Environment and Transportation (Transit))

A. O'Bumsawin provided an update from the Public Spaces Working Group by stating that a number of Site Plans have been reviewed and recommendation provided through the Planning Division during the spring and summer months. The comments have been well received resulting in dialogue and consultation. The Architects/Designers/Developers are open to change and are making revisions to the plans that will provide for an more accessible environment. A. O'Bumsawin also expressed his appreciation to the Planning Division for their continued support and commitment to improved accessibility from the new build stage.
