Pollinator Action Committee

Bee A Hero awards were presented at Committee of the Whole on November 3rd, 2020. The presentation went well, received very positive feedback, and served as an excellent engagement tool.

Active Transportation

- J. Morris reviewed the goals set for 2021:
- providing support to C. Marshall in carrying out the Active Transportation Master Plan
- providing input and encouraging the incorporation of Active Transportation friendly features in planning applications for new developments
- a challenge or competition to raise awareness and promote Active
 Transportation for example a car-less competition to encourage walking or cycling rather than driving for short distances
- moving forward with work on Queen's Square cycling infrastructure
- developing a bike share program for Lindsay

6. New or Other Business

- 6.1 Pollinator Uses in Solar Farms B. Snider
 - B. Snider provided a summary of the research he has conducted, and outlined some of the benefits of sheep grazing on solar farms. B. Snider was in contact with a solar grazing association in the United States, as well as with a farmer from the Ottawa area. Locally, B. Snider reports there are seven solar farms, and he will visit one next week for further research.
