3.1 Cannabis Regulation

6. Update from Economic Development Division

6.1 Comprehensive Rural Zoning By-Law Project

Jonathan Derworiz provided a brief overview of the upcoming agricultural land use consultation workshop planned for the morning of March 11, 2021 with ADAC members and a number of other sector representatives. Materials will be circulated in advance, and the workshop will be held over Zoom. The Issues and Methodology Report and Discussion Paper from 2020 will also be recirculated following this meeting to allow for familiarity of the issues by Committee Members.

6.2 SkillsAdvance Ontario Program Update

The Kawartha Lakes SkillsAdvance Ontario project has launched its first jobseeker cohort for manufacturing and will hold an agricultural jobseeker cohort beginning on March 1, 2021. Both jobseekers and employers with entry-level positions are being sought. The Incumbent Worker Training has also begun with several manufacturing employees taking upgrading skills training. An agricultural worker safety training program developed by the Ontario Federation of Agriculture as part of the Feeding Your Future program is being offered as a certificate program through University of Guelph Ridgetown for both jobseekers and incumbent workers. A collection of agricultural incumbent worker training for Grain Handling Safety will be offered by Acute Training from Feb 22 - Mar 24.

Courses include Lock-out-tag-out, Arc Flash Awareness, Confined Space Entry, and Confined Space Rescue.

6.2.1 SILO the film Screening & Community Discussion

A special Community Screening of SILO the Film will be hosted by Kawartha Lakes Agriculture Economic Development on March 19, 2021 at 7pm with support by local grain elevator operators to raise awareness of the dangers surrounding grain handling and the need for additional training and availability of appropriate safety equipment.

6.3 Rural Economic Development Project - Kawartha Choice FarmFresh Update

As part of the renewed partnership for delivery of the Kawartha Choice FarmFresh (KCFF) program, a Memorandum of Understanding has been sign with Peterborough & the Kawarthas Economic Development, and a funding grant has been received from the Rural Economic Development program through OMAFRA for the development of a new KCFF Website, the delivery of a 10-week Value-Added Food Business Bootcamp training program for 20 food businesses, the delivery of a 6-week Farm Financial Management Series for 30 farm businesses, and an Agri-Food Business Inventory and Needs Analysis. The project work will be completed by March 31, 2021.

7. News and Updates from Members

S. Weston reported that an expansion project is in the final planning stages at Green Tractors. Steel prices are moving up rapidly, so purchases should be made now and some products are in short supply. He is also doing some selective cutting of his hardwood bush.

R. Parker noted that sheep prices are strong.

Background Information to the Township of Howick Resolution No. 288-20 Requesting Amendments to the **Agricultural Tile Drainage Installation Act**

Rational for Proposed Amendments

Over the years, Howick Township staff have received many requests for tile drainage information on farmland. Usually these requests come after a change in ownership of the farm. Some of these drainage systems were installed recently but many are 30 to 40 or more years old. Many were installed by contractors who are no longer in business or who have sold the business and records are not available.

Information is generally available if the tile was installed under the Tile Drain Loan Program because a drainage plan is required to be filed with the municipality. If the tile system was installed on a farm without using the Tile Drain Loan Program, there likely are no records on file at the municipal office.

The other benefits to filing tile drainage plans with the municipality are identified in Section 65 of the Drainage Act.

- 65(1) Subsequent subdivision of land (severance or subdivision)
- 65(3) Drainage connection into a drain from lands not assessed to the drain
- 65(4) Drainage disconnection of assessed lands from a drain
- 65(5) Connecting to a municipal drain without approval from council

Section 14 of the Act states:

- (1) "The Lieutenant Governor in Council may make regulations,
 - (a) providing for the manner of issuing licences and prescribing their duration, the fees payable therefor and the terms and conditions on which they are issued;
 - (a.1) exempting classes of persons from the requirement under section 2 to hold a licence, in such circumstances as may be prescribed and subject to such restrictions as may be prescribed;
 - (b) Repealed: 1994, c. 27, s. 8 (5).
 - (c) establishing classes of machine operators and prescribing the qualifications for each class and the duties that may be performed by each class;

- (d) providing for courses of instruction and examinations and requiring licence holders or applicants for a licence under this Act to attend such courses and pass such examinations;
- (e) prescribing the facilities and equipment to be provided by persons engaged in the business of installing drainage works;
- (f) prescribing standards and procedures for the installation of drainage works;
- (g) prescribing performance standards for machines used in installing drainage works;
- (h) prescribing forms and providing for their use;
- (i) respecting any matter necessary or advisable to carry out effectively the intent and purpose of this Act. R.S.O. 1990, c. A.14, s. 14; 1994, c. 27, s. 8 (4, 5)."

I believe it would be beneficial if a regulation required the installer, of agricultural drainage, to file a plan of the drainage system with the municipality following completion of the work.

While most of Section 14 deals with contractor, machine and installer licences, I think that Section 14(f) or 14(i) may allow a regulation change. This would be a better solution than an amendment to the Act.

Recommendations:

- Request by municipal resolution that the Ministry of Agriculture, Food and Rural Affairs amend the Tile Drainage Installation Act and/or the regulations, under the Act, that would require tile drainage contractors file all farm tile drainage installation plans in the Municipality where the installation took place
