4.1 Report KLMHC20212-20

Report KLMHC02021-20 Old Gaol Lighting Update Angela Yurick, Facility Project Delivery Coordinator

A. Yurick presented the proposed lighting for the Old Gaol and clarified that it was for the doors which are currently accessible through the courtyard when the walls are demolished. The goal is to add extra security to these entrances at night. The Committee was supportive of the proposed option.

Councillor Ashmore asked about the lights at the front of the building which had been discussed previously by the committee. A. Yurick clarified that this was different lighting for a different area of the building.

The Committee discussed its continued concerns in general about the demolition of the Old Gaol walls. A. Hart clarified that a site visit was going to be set up with staff and that the proposed demolition would be discussed again at a later meeting.

Councillor Ashmore provided a verbal update on the Sturgeon Lake cabins. He has been in touch with staff from Parks Canada and is is currently looking for evidence of deed of property or tax payment with assistance from City staff. Progress has been slow. He is meeting with the CAO shortly and will mention that assistance is needed to expedite the process.

The Committee discussed the potential of sending correspondence to the CAO to let him know that this is a time sensitive matter.

- J. Garbutt provided a verbal update on the sign subcommittee. He has reached out to the BIA regarding business turnover as there has been a lot of activity in the downtown. The BIA is working on reporting issues with signage to City staff as they arise. J. Garbutt is currently working on getting the photos the subcommittee has taken to City staff.
- E. Turner has photographs of all of the downtown business which were taken when the HCD study was undertaken in 2016 and she will forward them to the subcommittee.

6. Correspondence

There was no correspondence reviewed by the Committee.

7. New or Other Business

7.1 180 Kent Street West Pavers

J. Garbutt had brought forward concerns regarding the pavers around 180 Kent Street West as part of the Downtown Lindsay reconstruction project. During

stakeholder meetings, there had been discussion about replacing all of the bricks around 180 Kent Street West with the red pavers which are going throughout the downtown but he had been informed that only the sidewalk would be replaced.

E. Turner provided an overview on the background of the design and consultation project, including the Committee's comments.

The Committee discussed the issue and brought forward concerns that the old and new bricks would not match aesthetically and would not be level. They discussed the fact that the older grey pavers seem to be in poor repair and look like they will need to be replaced soon. A. Adare suggested that the old pavers could be repurposed, possibly in Bobcaygeon where there are areas that need repair. A. Hart noted that while the Committee did not provide specific direction in writing regarding the treatment around 180 Kent Street West, they had consistently advocated for red brick.

E. Turner suggested that the best way to raise these concerns was through correspondence to Engineering staff.

7.2 28 Boyd Street Grants

A. Hart provided an update on the correspondence to Council that the Committee has discussed at their April meeting regarding the grants for 28 Boyd Street. He explained that he had decided not to send the letters because, after reviewing the grant criteria with E. Turner, it does not appear that the project is eligible for either grant and the decisions are made by Community Services as opposed to Council. E. Turner provided background to the Committee on the eligibility criteria and process.

E. Turner suggested that A. Adare, as the applicant, reach out directly to Community Services to discuss if she would like more information.

7.3 Committee ID Options

E. Turner provided an update on ID options for Committee members. She is able to get branded lanyards with name tags for identification. The Committee would like to have business cards with the Committee member name and the generic heritage email address. E. Turner is going continue to make arrangements for business cards.

7.4 Listing Properties

E. Turner is intended to bring another list of properties for addition to the Heritage Register to the Committee for review in June. She asked that Committee members provide her with properties they would like to see added to the Register.

7.5 Riverview Road and St. David Street Properties

J. Garbutt provided an update on the properties at 3 Riverview Road and 4 St. David Street. The properties have sold and are currently tenanted. It appears that 4 St. David Street is undergoing renovations.

7.6 West Street Condo Development

E. Turner provided an update on the condo development on West Street in Fenelon Falls that the Committee had provided comment on as A. Hart had noted they were currently preselling units. She confirmed that the development was still undergoing site plan approval and had not been fully approved yet.
