Bray Heritage Associates
Update/Discussion - Heritage Conservation Districts

Carl Bray and Marcus Laterneau participated in the meeting via conference call. D. Soule asked if the consultants had received questions from committee members for their consideration in today's discussion. The consultants confirmed that they had received one question, but asked for a verbal version of the second question. They requested that the Powerpoint presentation that had been forwarded to staff be displayed on the screen.

The consultants provided an overview of the rationale behind their recommendation of the boundaries for the downtown Lindsay District and answered questions. They noted that the boundary falls on the west side of Lindsay Street, except for the two buildings at the bottom of Kent Street that are included because they are a part of the vista for the downtown. The building to the north of the Academy Theatre on Lindsay Street is considered to be a part of the earlier old mill settlement and the buildings to the south of the former Chamber building are considered to be a part of the old Purdy's Mill development – both of these areas were part of an earlier sequence of development that occurred prior to the Kent Street downtown area.

C. Bray and M. Laterneau noted that this does not mean that these buildings do not have historical value or significance, but their significance is associated with a different era and pattern of development in Lindsay's history. They are properties that could be protected by Part IV designations and through adjacency. They will recommend in the Plan that the definition for adjacency for this district be part of an amendment to the Official Plan so that it extends beyond the normal 'continuous' interpretation and includes properties on the east side of Lindsay Street.
