B. Condie advised that the City is in the process of creating a new website and the Consultants creating the new site, ESolutions, have provided information on accessible websites. B. Condie reviewed the power point presentation from ESolutions. The Committee discussed the proposed Accessibility Statement for the new website. A discussion ensued and the revision suggested. B. Condie agreed to share the suggested changes with staff.

Judy Currins, City Clerk, provided an overview of Council Report CLK2017-001, 2018 Municipal Election Voting Method. Ms. Currins advised that the Report recommends that telephone/internet voting be used for the 2018 Municipal Election. Ms. Currins responded to questions from the Committee. It was noted that telephone/internet voting is accessible.

5.3 Parks and Transportation Working Group

N. Price provided an update on transit matters, the Committee was advised that all transit buses now have audio/visual stop calling. In addition, there are now three (3) LIMO buses in service to accommodate ridership demands.

N. Price also provided an update on parks matters, the Committee was advised that in conjunction with the Parks Master Plan residents were able to complete a survey and identify accessibility issues at parks within Lindsay. The Parks Master Plan is in the planning stages and staff are gathering information at the current time.

5.4 Built Environment Working Group

B. Huskinson advised that the Built Environment Working Group will be reviewing three (3) sets of plans. The plans involve a commercial establishment in Lindsay; a multi-unit residential structure in Lindsay and a commercial gas station establishment in the former Laxton Township.

The Committee discussed the number of accessible parking spaces that are available for the multi-unit residential structure in Lindsay. It was noted that the property may benefit from additional accessible parking spaces.

The Built Environment Working Group will be reviewing the plans and will forward comments to the Planning Department for consideration.

5.5 Councillor's Update

Councillor Strangway provided the following updates:

- A Report authorizing the purchase of a new transit bus will be considered by Council at the January 24th Regular Council Meeting.
- The City's new clear bag program is underway and the uptake has been very positive. The City had 70-75% compliance after the first week.

- Issues have been raised regarding the lack of a warm area to view the ice surface at the Lindsay Recreation Complex. Staff are looking into how to remedy the issue.
- The Core Service Review of arena and community halls concluded. Council directed that the status quo remain for the time being.
