5.1 Accessibility Coordinator Update

B. Condie advised that a final report on the Age-Friendly Business Engagement Strategy was presented to Council on April 11, 2017 and thanked the Committee for their participation and recommendation on the final documents. B. Condie provided each member with the final draft of the Age-Friendly Business Guide.

B. Condie advised that she is drafting the multi-year ((5) five year) accessibility plan. She will be meeting with staff regarding the document in June.

B. Condie advised that the Accessibility Design Standards are still in draft form and there are plans to introduce the Standards during 2017.

# 5.3 Parks and Transportation Working Group

N. Price advised the Lindsay Parks Committee have not met.

N. Price expressed a concern regarding the seniors discount token fee not shown in the consolidated fees by-law basically eliminating the discount. At one time seniors were provided with 14 tokens vs. the 12 tokens for the same adult fee. N. Price advised that he was going to take this to the Transit Advisory Board for discussion. N. Price noted that the new bus shelter on Kent Street in front of A&W is a great location.

B. Huskinson advised that comment was provided to City Staff on the City Housing complex on Paul Street and the Multi-Use Administration and Housing complex that is planned.
