5.1 **PRC Activity Summary Spreadsheet**

6. **LANDFILL COMPLAINTS**

Seven landfill complaints were received from the adjacent neighbour regarding off site litter.

7. **LEACHATE OUTBREAKS**

No leachate outbreaks have been reported. Committee was informed of 20 to 30 L of hydraulic oil that was spilled in cell 6. This was immediately contained by covering with sand and reported to SAC as required.

8. OTHER NEW BUSINESS

8.1 Reuse Partnership- Pilot Program

The City is working in partnership with Habitat for Humanity to setup a bin at Lindsay Ops to pilot a reuse drop off program from May to September, 2017. MOECC is in support of this pilot and advised if this becomes a long term program would require an amendment to the ECA. Staff will continue to update the committee as the pilot progresses.

8.2 Compost Pad MOECC Comments & City Response

Committee reviewed MOECC's comments and the City's response regarding the storm water pond associated with the new compost pad. Amendment application is ongoing and further correspondence will be circulated to the committee.

Committee had comments regarding the revised tipping fees for leaf and yard waste and was supportive of up to 150 Kgs free and more materials chargeable.

8.3 Amendment to ECA

Committee was circulated the finalized amendment for alternative daily cover including partially composted material and steel plates. It was noted that in this amendment an update was also made to the HHW depot hours to be the same as the regular hours of operation and ability to request a change in grinding frequency of course leaf and yard material if required.

8.4 C&D Waste Diversion Study

An update was provided to the committee based on finalized work plan, associated timelines and a recent presentation made to the Waste Strategy Task Force. Committee requested copy of the presentation be circulated.

8.5 Curbside Collection Study
