5.1 **PRC Activity Summary Spreadsheet**

6. **LANDFILL COMPLAINTS**

On Sunday June 18 the City received a phone call from Mr. Wilson noting off site litter on May 16, 17, 19, 23, as well as June 2, 3 and 8. Also, he noted there was an odour on June 9. Summer staff are regularly scheduled for litter collection as required.

7. **LEACHATE OUTBREAKS**

During regular inspection on June 12 a leachate outbreak was noted on the north side of the road to the tip face. On June 14 a contractor was onsite to repair this outbreak by installing a French drain to ensure that this area is collected by the leachate collection system. This has been reported to MOECC on June 27 within the required ECA timelines.

8. **OTHER NEW BUSINESS**

8.1 **2016 Annual Report Presentation & Discussion**

Staff provided a PowerPoint presentation summary to the committee. There were items the committee would like updated in the presentation including removing acronyms, updated numbers, etc. Any items for follow up will occur at the July meeting.

Also, some general discussion on the 2016 report included water quality in the Scugog River and reduction of PCB monitoring to discuss at the July meeting.

## **8.2 Sewage Works ECA Amendment**

Heather confirmed with the committee that the City has the approvals required to build the relocated compost pad and associated pond in both the sewage and waste ECAs. An additional amendment is required in the Waste ECA to update the new contingency plan for the pond and add the existing leachate collection system. When the notice is available it will be circulated to the committee.

## **8.3 C&D Draft Report & Recommendations**

The committee discussed the draft Reclay C&D Waste Recycling Report with questions regarding shingles and next steps for this program. Staff advised that there is no local market to recycle shingles. Also, that next a staff report will be prepared with the Reclay report attached for the August Council meeting.
