5. **NEW BUSINESS**

5.1 **Curbside Collection Study Reclay Presentation**

Dave Yousif from Reclay outlined Construction & Demolition recycle program. Information was provided on components of study, policy suggestions, business feedback as well as a draft financial breakdown. Committee discussed project and draft recommendations.

Curbside Collection program study to take place April - June 2017. Components of study will include a curbside waste audit, resident survey and looking at programs in municipalities that are similar to CKL. Will report back to Task Force in June.

Staff provided update on Provincial Legislation effective March 31, 2017. Resource Productivity and Recovery Authority will replace Waste Diversion Ontario. New body to oversee Waste Acts, gradually moving towards 100% producer funding as opposed to the current 50/50 model.
