

## Ministry of Transportation, Ontario Replacement of Stoney Creek Culverts on Highway 35 City of Kawartha Lakes Noise By-Law Exemption Request

The Ministry of Transportation, Ontario (MTO) retained Dillon Consulting Limited to complete the Class Environmental Assessment (Class EA) and Design for the replacement of the Stoney Creek culverts located approximately 6 km south of Lindsay in the City of Kawartha Lakes. The site location is shown on **Figure 1**. The project is being completed in accordance with the MTO's Class EA for Provincial Transportation Facilities (2000) for a Group 'C' project.

To address future operations, capacity and safety requirements along Highway 35, a planning and preliminary design study was completed in 2007 for a future four lane expansion. The Stoney Creek culverts were identified for replacement as part of the highway expansion.

The Ministry of Transportation, Ontario (MTO) retained Dillon Consulting Limited to undertake a Group 'C' Class Environmental Assessment (EA) for Provincial Transportation Facilities to determine the best option for rehabilitating or replacing the existing Stoney Creek culverts, including construction staging alternatives. The culverts are being replaced prior to the future four lane expansion to address the existing condition of the culverts. The replacement will only accommodate the existing two lane Highway 35 cross-section.

Rehabilitation and replacement alternatives were considered. Replacement has been recommended.

Three construction staging alternatives were considered for the replacement of the Stoney Creek culverts. The alternatives considered were:

- Detour around the construction zone with a temporary closure of Highway 35 **Recommended**
- Maintain two lanes of traffic on Highway 35 through the construction zone
- Maintain one lane of traffic on Highway 35 through the construction zone using temporary traffic signals.

Each construction staging alternative was evaluated based on traffic impacts, environmental impacts, property impacts, utilities impacts, relative cost, and, construction complexity/duration.

The detour alternative has a significantly lower cost and the lowest impact on the environment, property and utilities, reduces construction complexity, and minimizes construction duration.

It is anticipated that work will begin in 2017 and that traffic will be diverted to Kawartha Lakes Road (KLR) 31 and Highway 7 while works are completed at Stoney Creek. Considering the higher traffic volumes which occur during the summer, the highway closure will occur after Labour Day and will last up to eight weeks.

In order to complete construction within an eight week period or less, night work and weekend work may be required. By way of this letter, we respectfully request an exemption from the City's By-Law to Regulate Noise (2005-2025), to permit **nightly construction between 9:00 p.m. and 7:00 a.m. and work on Sundays and statutory**
