#### **BY-LAW 2017-**

## A By-law to Amend Several By-law Relating to the Sale of Land in the City of Kawartha Lakes

### **Recitals**

- 1. Several By-laws have been passed by Council relating to the sale of land over the past few months. Each contained a statement that referred to registration at the Land Titles Office.
- 2. The City has been informed by the Land Titles Office that this type of by-law does not need to be registered as the purchase will be registered.
- 3. Due to this process change, the section of the by-law that refers to the effective date being at the time of registration needs to be amended.
- 4. This by-law makes the required wording change.

# Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2017-

Section 1.00: Definitions and Interpretation

1.01 **<u>Definitions</u>**: All definitions contained with the original by-law will have the same meaning within this by-law.
