**THAT** Council approve the option to renew this tender for an additional three, one year terms, pending budget approval and vendor performance;

**THAT**, subject to receipt of the required documents, the Mayor and Clerk be authorized to execute the contract to award; and

## **Background:**

Tender No. 2017-25-OT was called to provide all labour, fuel, equipment and materials necessary to perform laboratory services for landfill monitoring analysis, including sample packaging material and delivery costs for testing.

Tender 2017-25-OT was advertised in accordance with the City's Purchasing Policy. The tender closed on Thursday, March 2, 2017, and was opened in public by: Andy Letham, Mayor and Karen Buckley, Buyer, with the following results:

Bids were checked for mathematical errors and conformity to the tender requirements. After evaluation, the bids received from ALS Canada Ltd. and SGS Canada Inc. were adjusted to reflect the correct total cost of the project, as noted in the chart above.

# Rationale:

The City is required by the Ministry of Environment and Climate Change (MOECC) through landfill Environmental Compliance Approvals (ECA) to monitor surface water and groundwater associated with both open (5) and closed (11) City owned landfill sites to ensure environmental compliance at each site. Chemical analysis of the samples collected from monitoring is also an ECA requirement and must be sent to an accredited laboratory to provide accurate and consistent results for annual reporting to MOECC. The parameters to be sampled, monitoring frequency, number of samples and lab detection limits are outlined within each site ECA. Tender 2017-25-OT reflects the City's current MOECC laboratory regulatory requirements.

# **Other Alternatives Considered:**

No other alternatives are being considered at this time as the recommendation to award falls within budget and was achieved through an open, fair and transparent competitive procurement process.

#### **Financial Considerations:**

Laboratory services for environmental monitoring at various open and closed landfill sites is expensed through the department's operational budget on an annual basis for each individual landfill site.

Sufficient funds are available in the public works 2017 operating budget to cover costs associated with this project.
