#### BY-LAW 2017 -

BY-LAW TO ESTABLISH A PARCEL OF LAND LEGALLY DESCRIBED AS PART OF E ½ LOT 24 CONCESSION 6, IN THE GEOGRAPHIC TOWNSHIP OF OPS, CITY OF KAWARTHA LAKES, DESIGNATED AS PART 1 ON REFERENCE PLAN 57R10569, BEING PART OF PIN:63209-0076(LT) AS PUBLIC HIGHWAY

# **Recitals**

- The Development Engineering Division of the City of Kawartha Lakes has identified that Part E ½ Lot 24, Concession 6 in the former Geographic Township of Ops, City of Kawartha Lakes designated as Part 1 on Plan 57R10569 (Part of PIN: 63209-0076 (LT)) is required for future road purposes.
- 2. Section 31 of the *Municipal Act, 2001* authorizes Council to establish land as public highway by by-law.

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2017-

Section 1.00: Definitions and Interpretation

- 1.01 **Definitions**: In this by-law,
  - "City", "City of Kawartha Lakes" or "Kawartha Lakes" means The Corporation of the City of Kawartha Lakes.
  - "City Clerk" means the person appointed by Council to carry out the duties of the clerk described in section 228 of the *Municipal Act, 2001*.
  - "Council" or "City Council" means the municipal council for the City.
  - "Manager, Realty Services" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

## 1.02 Interpretation Rules:

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.
- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.
- 1.03 <u>Statutes</u>: References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability**: If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

### Section 2.00: Public Highway

2.01 Public Highway: The parcel of land legally described as Part E ½ Lot 24, Concession 6 in the former Geographic Township of Ops, City of Kawartha Lakes designated as Part 1 on Plan 57R10569 (Part of PIN: 63209-0076 (LT)), is hereby established as public highway and future

extension of Simpson Road, in the former Geographic Township of Ops, City of Kawartha Lakes.
