Background:

Between 2012 and 2014, the City of Kawartha Lakes operated a heritage-themed trolley. The Trolley project was initially established as a pilot project to promote heritage and tourism across the City. The Trolley was part of numerous special events in various communities across the City including Santa Clause Parades in Fenelon Falls, Omemee and Lindsay, RibFest and the Lindsay Central Exhibition.

The Kawartha Lakes Municipal Trolley Management Board was established in 2012 to manage the municipal interests of the Kawartha Lakes Trolley.

Rationale:

Due to revenue challenges in the trolley business plan and deteriorating condition of the Trolley it was felt that the maintenance and repair costs far outweighted the profitability of the Trolley. In the spring of 2015, the Trolley was removed from service and in the fall of 2016, was sold following the City's Purchasing Policy.

As the City no longer owns or operates the Trolley, there is no requirement for the Kawartha Lakes Municipal Trolley Management Board. It is therefore recommended that the Kawartha Lakes Municipal Trolley Management Board be dissolved and all current members be notified of the dissolution and thanked for their service.
