A By-law to Amend By-law 2016-206, being the Consolidated Fees By-law in the City of Kawartha Lakes (Amendment No. 10)

Recitals

- 1. By-law 2016-206, being a By-law to establish and require payment of fees for information, services, activities and use of City property in the City of Kawartha Lakes was adopted by Council on November 8, 2016.
- At the August 14, 2018 Regular Council Meeting, Council approved Resolution CR2018-512 for an update to the General Inspections (all Regulatory By-law Inspections not including Property Standards and Clean and Clear) Fees.
- 3. This by-law amends By-law 2016-206 to reflect this decision.

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2018-___.

Section 1.00: Definitions and Interpretation
