Background:

This quotation is for the work pertaining to the Capital program RD1814 Gravel Road Rehabilitation. The work will include ditching, culvert replacement, berm removal and road base repair.

The Request for Quotation (RFQ) 2018-86-CQ Gravel Road Rehabilitation was released and advertised in accordance with the Purchasing Policy.

The RFQ closed on Thursday September 6, 2018 and was opened in public by Mayor, Andy Letham and Buyer, Linda Lee.

In accordance with the Purchasing Policy the results of a competitive procurement process are considered to be irregular when fewer than three submissions are received in a formal competitive procurement process.

Bids received were checked for mathematical errors and compliance to the bid call.

Rationale:

Staff recommends that Four Brothers Construction Corporation be selected for the award of Quotation 2018-86-CQ Gravel Road Rehabilitation for the quoted price of \$1,078,777.50 plus HST.
