

# The Corporation of the City of Kawartha Lakes

## By-Law 2018-

### **A By-law to Provide for the Erection of Stop Signs in the City of Kawartha Lakes (various intersection Thurstonia and Oakwood) in the City of Kawartha Lakes**

#### **Recitals**

1. The Engineering and Corporate Assets Department has recommended that stop controls be implemented at various intersections in Thurstonia and Oakwood.
2. At the September 25, 2018 Regular Council Meeting, Council adopted Resolution Numbers CR2018-XXX and CR2018-XXX approving of the Traffic Control in this area.
3. The Municipal Act, 2001, S.O. 2001, c. 25 authorizes municipal councils to pass by-laws respecting traffic on highways under the jurisdiction, in conjunction with the provisions and requirements of the Highways Traffic Act, R.S.O. 1990, c.H.8.
4. This by-law enacts the approved traffic control.

**Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2018-      .**

#### **Section 1.00: Definitions and Interpretation**

1.01 **Definitions:** In this by-law,

**“City”, “City of Kawartha Lakes” or “Kawartha Lakes”** means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;

**"City Clerk"** means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;

**“Council” or “City Council”** means the municipal council for the City;

**“Director of Engineering and Corporate Assets”** means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.

1.02 **Interpretation Rules:**

(a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.

(b) The words “include” and “including” are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.

(c) Except as otherwise provided in section 1.01, the words and terms used in this by-law have the same meaning as the words and terms used in the Highway Traffic Act, R.S.O. 1990, c.H.8.

- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.
- 1.04 **Severability:** If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be severed from the balance of the by-law, which shall continue to operate in full force and effect.

## **Section 2.00: Regulate Traffic**

- 2.01 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of First Street and Hotel Road in Thurstonia.
- 2.02 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Second Street and Hotel Road in Thurstonia.
- 2.03 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Third Street and Hotel Road in Thurstonia.
- 2.04 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Clipper Street and Pavillion Road in Thurstonia.
- 2.05 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Second Street and Pavillion Road in Thurstonia.
- 2.06 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Third Street and Pavillion Road in Thurstonia.
- 2.07 **Stop Control:** Stop sign shall be erected at the east corner of the intersection of Thornton Street and Silver Birch Street in Thurstonia.
- 2.08 **Stop Control:** Stop sign shall be erected at the west corner of the intersection of Thornton Street and Silver Birch Street in Thurstonia.
- 2.09 **Stop Control:** Stop sign shall be erected at the west corner of the intersection of Alfred Street and Silver Birch Street in Thurstonia.
- 2.10 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of McLernon Street and Birchcliff Avenue in Thurstonia.
- 2.11 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Hollyville Boulevard and Birchcliff Avenue in Thurstonia.
- 2.12 **Stop Control:** Stop sign shall be erected at the north corner of the intersection of Birchcliffe Avenue and Birchcliff Avenue in Thurstonia.
- 2.13 **Stop Control:** Stop sign shall be erected at the south corner of the northern intersection of Grant Drive and Brenda Boulevard in Oakwood.

- 2.14 **Stop Control:** Stop sign shall be erected at the west corner of the southern intersection of Brenda Boulevard and Grant Drive in Oakwood.
- 2.15 **Stop Control:** Stop sign shall be erected at the west corner at the intersection of Albert Street and Grant Drive in Oakwood.

### **Section 3.00: Enforcement, Offence and Penalties**

- 3.01 **Enforcement:** This by-law may be enforced by every police officer.
- 3.02 **Obstruction:** No person shall hinder or obstruct, or attempt to hinder or obstruct, any person exercising a power or performing a duty under this by-law.
- 3.03 **Offence and Penalty:** It is an offence for a person to contravene any provision of this by-law, and every person who contravenes this by-law is guilty of an offense and, on conviction, is liable to a fine in accordance with the provisions of the Provincial Offences Act, R.S.O. 1990, Chapter P. 33, as amended and the Highway Traffic Act, R.S.O. 1990, c.H.8 and any other applicable penalty.

### **Section 4.00: Administration and Effective Date**

- 4.01 **Administration of the By-law:** The Director of Engineering and Corporate Assets is responsible for the administration of this by-law and for the installation and maintenance of the traffic control signal systems, other traffic control signals, and signs authorized by this by-law
- 4.02 **New Traffic Control Signals:** In accordance with the requirements of subsection 144(31) of the Highway Traffic Act, R.S.O. 1990, c.H.8., the Director of Engineering and Corporate Assets is designated by Council as the person whose approval is required prior to the erection or installation of any new traffic control signal system or traffic control signals used in conjunction with a traffic control signal system that has been authorized by this by-law.
- 4.03 **Effective Date:** This By-law shall come into force on the date it is finally passed, and after properly worded signs have been erected.

By-law read a first, second and third time, and finally passed, this 25<sup>th</sup> day of September, 2018.
