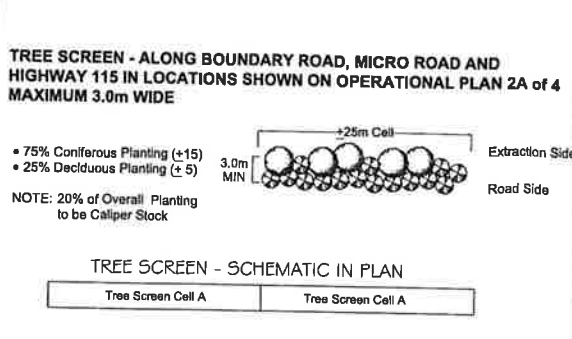

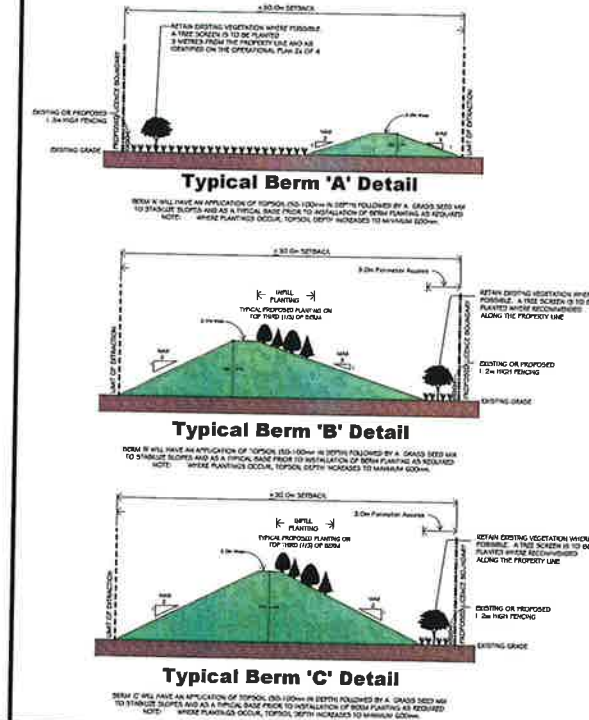
Typical Slope Details

3. The elevation of the ground water table is relatively flat and stable at approximately 317 msl. Water level elevations have varied from ± 316.1 msl to ± 318.0 msl in the pit extension area. The proposed pit floor elevation ranges from 320 to 320.5 msl, based on a conservative 2 m cut set from the high water level recorded (318.0 msl).
