Background:

The Request for Proposal 2018-30-CP Consulting Services for Development of Park Conceptual Design, Permitting and Public Consultation (Bobcaygeon Trailer Park and Beach Park) was released and advertised in accordance with the Purchasing Policy and was approved at Council on April 10, 2018 with the following resolution.

That Report PUR2018-016, **Proposal 2018-30-CP Consulting Services for Development of Park Conceptual Design, Permitting and Public Consultation (Bobcaygeon Trailer Park and Beach Park)**, be received;

That Landscape Planning Ltd. of Richmond Hill, being the highest scoring proponent be selected for the award of Proposal 2018-30-CP Consulting Services for Development of Park Conceptual Design, Permitting and Public Consultation for a proposal cost of \$131,310.00 plus HST;

That subject to the receipt of the required documents, the Mayor and City Clerk be authorized to execute the agreement to award RFP 2018-30-CP; and

That the Financial Services Division be authorized to issue a purchase order.

The goal of the procurement was to secure a Landscape Architect to complete a conceptual design for a Destination Style Waterfront Park on a property in Bobcaygeon, formerly utilized as a seasonal trailer park and community park. The Parks, Recreation and Culture Division was looking for a knowledgeable consultant that possessed the required technical background and experience to complete the conceptual design meeting all the necessary technical components while capturing and fulfilling the needs of this unique community and property. Ten to fifteen landscape architects from all over the province submitted proposals during this procurement process.

Landscape Planning Ltd. was selected as the highest scoring proponent by the evaluation committee. The proposal made a clear representation that Landscape Planning Ltd. had the required team to complete the conceptual design on time and on budget.

Landscape Planning Ltd. began the process by meeting with City staff to discuss potential options for the site and challenges the site would impose. Meetings with multiple community partners and a number of governing agencies were held, collecting information from each. The first conceptual design was produced keeping everyone's input and needs in mind and it was presented during the first public meeting. The community had an opportunity to provide feedback based on the initial concept and all the information was collected, categorized and detailed. Once the comment period ended Landscape Planning Ltd. completed the final conceptual design and presented it in the final public meeting which received positive feedback from the community stakeholders and the public.

During the data collection process Landscape Planning provided and completed many technical reviews and reports along with their sub-consultants such as:

- Permit & Approval Pre-Approval
- Site Servicing Review & Needs Assessment
- Site Survey
- Site Drainage & Grading Review
- Boat Docking Capability
- Accessibility and Play for all
- Detailed Cost Estimates
 - Detailed Design & Contract administration
 - Detailed Construction Estimate

Included in the scope of work for the conceptual design of Bobcaygeon Beach Park was the requirement for Landscape planning to provide the City with a cost estimate, detailed design, contract administration and permits and testing. Total of this work is \$443,070.00 not including HST.

During the entire design process Landscape Planning Ltd. was able to keep the project on schedule and achieved all milestone dates for important tasks. Their attention to detail and professionalism was apparent during the entire process and their quality of work was impressive.

Rationale:

Based on the above information, staff recommends that Landscape Planning Ltd. be awarded the design and contract administration for Bobcaygeon Beach Park at a total cost of \$443,070.00 not including HST.

Other Alternatives Considered:

No other alternative is being considered as this is compliant with the Canadian Free Trade (Article 512 (f)) and the Canada-European Union Comprehensive and Economic Trade (Article 19.12.6) Agreements for Limited Tendering:

“if a procuring entity procures a prototype of a first good or service that is developed in the course of, and for, a particular contract for research, experiment, study, or original development. Original development of a first good or service may include limited production or supply in order to incorporate the results of field testing and to demonstrate that the good or services is suitable for production or supply in quantity to acceptable quality standards, but does not include quantity production or supply to establish commercial viability or to recover research and development costs;”

Financial/Operation Impacts:

Funds for the Bobcaygeon Beach Park were identified in the 2019 Capital Budget under 950190103.
