

**The Corporation of the City of Kawartha Lakes**  
**By-Law 2020-XXX**

**A By-law to apply a Temporary Amendment to the Consolidated Fees**  
**By-law 2018-234 to Revise Certain Fees for the 2020.**

**Recitals**

1. Section 391 of the Municipal Act 2001, S.O. 2001, as amended, provides for a municipality to pass by-laws imposing fees or charges on persons for services and activities provided or done by or on behalf of it, for cost payable by it for services or activities provided or done by or on behalf of any other municipality or local board, and for the use of its property including property under its control.
2. The Fees and Service Charges By-law 2018-234 was adopted December 11, 2018 and was last consolidated December 10, 2019.
3. Due to the COVID-19 Pandemic, individuals, businesses and organizations, specifically Patios, Retailers, Special Events and Farmers Markets have been impacted by the restrictions of the Provincial Orders under the Emergency Management and Civil Protection Act. This has financially impacted individuals, businesses and organizations by experiencing delays from opening or canceling events and/or operating within a limited capacity, which has resulted in substantial local economic impacts. Revising certain fees would provide assistance to those individuals, businesses and organizations as part of the economic recovery plan.
4. This by-law reduces certain fees related to Licenses, Permits, Parking and Noise, that apply to Special Events, Patios, Retailers and Farmers' Markets for the duration of the 2020.

Accordingly, the Council of the Corporation of the City of Kawartha Lakes enacts this By-law 2020-XXX.

**Section 1.00: Definitions and Interpretation**

**1.01 Definitions:**

All defined terms in the amending By-law take their meaning from By-law 2018-234 of the City of Kawartha Lakes.

**1.02 Statutes:**

References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.

**1.03 Severability:**

If a court or tribunal of competent jurisdiction declares any portion of this by-law to be illegal or unenforceable, that portion of this by-law shall be considered to be

severed from the balance of the by-law, which shall continue to operate in full force and effect.

## **Section 2.00: Amendment Details**

2.01 That the following fees contained in Consolidated Fees By-law 2018-234 be amended for 2020:

3.01 Administration of the By-law: The Director of the City Departments are responsible for administration of the respective department fees as approved.

3.02 Effective Date: This By-law shall be in effect May 1<sup>st</sup>, 2020 until December 31, 2020.
