The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 9, 10, 11 and 12, 2020.

The following complaints were inspected: Log # 001135-20, Log #001376-20, #002475-20, #002644-20 and #002920-20 related to staffing of Registered Nurses in the home.

During the course of the inspection, the inspector(s) spoke with Director of Care (DOC), Assistant Director of Care (ADOC), Registered Nurse (RN), Registered Practical Nurse (RPN) and nursing scheduler.

The Inspector reviewed of the RN schedules, time sheets and the licensee's RN contingency plan.

1. The licensee failed to ensure that a least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times.

Complaints were received by the Director related to RN staffing at the home.

Inspector #194 reviewed the registered nursing schedules for the identified period indicating that on several shifts there was no registered nurse who were both an employee of the licensee and a member of the regular nursing staff on duty and present working in the home:

During interview with Inspector #194, RN #102, RN #100, RPN #101 and RPN #107 all stated that they were aware that there were shifts where there were no RN's on duty and present in the home.

During interview with Inspector #194, the DOC and nursing scheduler indicated, that during the identified period, several shifts were identified, where there was no registered nurse who was both an employee of the licensee and member of the regular nursing staff on duty and present in the home.

The licensee failed to ensure that there was a least one registered nurse who is an employee of the licensee and a member of the regular nursing staff on duty and present during the reviewed period. [s. 8. (3)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring that at least one registered nurse who is both an employee of the licensee and a member of the regular nursing staff of the home is on duty and present in the home at all times, to be implemented voluntarily.
