**That** the Procurement Division be authorized to issue a purchase order.

## **Background:**

At the Council Meeting of July 28, 2020, Council adopted the following resolution:

**That** Report WM2020-009, **Construction and Demolition Recycling Pilot Program**, be received;

**That** Council approve an extension of the pilot to December 31, 2021 with consideration of an operating budget of \$155,000 in 2021; and

**That** Staff report back to Council on the success of the construction and demolition waste recycling pilot program by June 30, 2021 with future program recommendations and associated budget.

**That** Durham Disposal Services Ltd. be selected for the award of the transportation and recycling of mixed construction and demolition material at the Lindsay Ops Landfill, on an as required basis, at a total estimated cost of \$152,319 not including HST;

**That** subject to receipt of the required documents, the Mayor and Clerk be authorized to execute the agreement to award the contract; and

**That** the Procurement Division be authorized to issue a purchase order.

## **Carried**

This report addresses the extension of the services for the pilot project.

### **Rationale:**

The current contract with Durham Disposal Services Ltd. expires December 31, 2020. As Council has approved the extension of the pilot project and that Council has previously approved the award to the Durham Disposal Services Ltd. for 2020, an extension of the current contract is in the best interest of the City.

In January 2018 a competitive request for proposal was issued for the transportation and processing construction and demolition material from the Lindsay Ops and Fenelon landfills. The City received no submissions. Staff continued to work to find programs to reduce the amount materials entering our landfills. After receiving no bids on our clean wood waste recycling program that closed on January 6, 2020, Staff reached out to Durham Disposal Services (who previously competed this work in 2019) to understand the issue with bidding on this work. Durham Disposal explained their issues, and through negotiations with the City provided an alternative proposal. This was approved by Council at the March 19, 2020 Council meeting. As a result of this process, staff do not see a benefit to issue another procurement document and are recommending the extension of the current contract within the pilot project.

Staff recommends that the current contract with Durham Disposal Services Ltd. for the transportation and recycling of mixed construction and demolition material at the Lindsay Ops Landfill, on an as required basis, be extended to December 31, 2021 for a total estimated cost of \$152,319 not including HST.

### **Other Alternatives Considered:**

No other alternatives are being considered as there is a current contract in place.

### **Alignment to Strategic Priorities**

This report contributes to the Council Adopted Strategic Plan, namely Strategic Action 3.1.2 which is "Executing the Waste Management Strategy". This report aligns with the City's Integrated Waste Management Strategy to divert materials from landfill and find further recycling opportunities to save landfill space.

Also, the proposed C&D recycling program aligns with Goal #3 of a "Healthy Environment". The act of construction and demolition waste diversion aligns with the City's vision of a naturally beautiful community that protects our local environment, enhances water quality and creates an improved quality of life.

### **Financial/Operation Impacts:**

There are adequate funds to support the recommendations in this report (\$152,319) proposed in the 2021 Solid Waste operating budget (\$155,000).

The work is on an as required basis and staff will monitor to ensure that costs stay within the allocated budget.
