### **Background:**

As part of the City's Core Service Review, the Limited Service Agreement (LSA) program was reviewed by Public Works staff in consultation with the Office of Strategy Management.

At the Council Meeting of March 21, 2017 Council adopted the following resolution with respect to LSAs for Private Roads:

**RESOLVED THAT** the City continue to provide Limited Service Agreements on Private Roads for any existing agreements including any renewals and pending applications;

**THAT** no new agreements be accepted for Limited Service Agreements on Private Roads; and

**THAT** staff be directed to include a program for consideration within the 2018 Operating Budget to determine ownership of unknown road segments.

At the Council Meeting of April 18, 2017 Council adopted the following resolution with respect to LSAs and snowplowing on Unassumed Roads.

**RESOLVED THAT** Report PW2017-004, **Limited Service Agreements - Unassumed Roads**, be received;

**THAT** the policy entitled Seasonal Level of Service Policy appended to Report PW2017-004 be adopted and numbered for inclusion in the City's Policy Manual;

**THAT** staff be directed to issue notice to Fulsom Crescent and Mink Alley that winter control services will not be provided after April 30, 2019; and **THAT** all existing Limited Service Agreements for Unassumed Roads be cancelled effective April 30, 2017 and service be continued through the Seasonal Level of Service Policy.

**RESOLVED THAT** due to the unique circumstances, that staff be directed to continue winter control only for Antiquary Road.

### Rationale:

There are a number of Limited Service Agreements for private roads that require renewal. In reviewing the services provided it was discovered that winter control services have been provided to a number of private roads even though it was not included in their legal agreement.

A total of eleven (11) private roads receive snowplowing, however only three (3) roads have this service included in their legal agreement.

In order to remain consistent with Council's direction regarding snowplowing on unassumed roads through the transition to the new Seasonal Level of Service Policy, Staff recommends that winter control services be discontinued on private roads. Those roads that have winter maintenance included in their current agreement will be advised that the service will be ending. In order to provide sufficient time for the road associations to make other arrangements for snowplowing services, it is recommended to discontinue the service for all roads as of April 30, 2019.

Council is aware that a previous resolution directs Staff to budget funds in the 2018 operating budget to undertake a comprehensive review of road ownership

within the municipality. Through this review, there is a possibility for Staff to uncover situations where Staff are providing service to private roads. Should it be discovered we are providing service to unassumed or private roads, upon completion of the review Staff will report back to Council with recommendations to obtain direction for maintenance services.

#### Other Alternatives Considered:

Alternative 1: Council could choose to continue winter maintenance services on private roads with an LSA for those groups where winter control is already included in the agreement. Council may recall this decision was made for Antiquary Road due to extenuating circumstances. Staff do not recommend this alternative as the extenuating circumstances that led to the decision on Antiquary Road do not exist for these groups. The motion would be:

**THAT** winter maintenance be continued as part of the Limited Service Agreements currently in place for Admiral Drive, North Shore Road, and Sunset Beach Rd.; and

**THAT** staff be directed to issue notice that winter maintenance will be discontinued effective April 30, 2019 on Alton Rd., Betty's Bay Rd., Cedar Point Rd., Centennial Dr., Gillis St., Killarney Bay Rd., Leslie Frost Lane, and Rustic Trail.

<u>Alternative 2:</u> Council could choose to continue providing winter maintenance services to all the private roads that currently receive the service. Staff do not recommend this alternative as this does not align with the previous decision on Municipally Unassumed Roads. In this case, the motion would be:

**THAT** winter maintenance services be included in the Limited Service Agreements for Admiral Dr., Alton Rd., Betty's Bay Rd., Cedar Point Rd., Centennial Dr., Gillis St., Killarney Bay Rd., Leslie Frost Lane, North Shore Rd., Rustic Trail and Sunset Beach Rd.

## **Financial/Operation Impacts:**

Limited Service Agreements were designed for summer maintenance only and were never intended to include winter control services. By discontinuing this service to private roads, resources can be redistributed to the City's assumed road network.
