Recitals

Section 1.00: Definitions and Interpretation

 - "Corporate Services Manager, Revenue and Taxation/Deputy Treasurer" means the person who holds that position and his or her delegate(s) or, in the event of organizational changes, another person designated by Council.
- 2.04 <u>Amendment to Section 3.01:</u> Section 3.01 to By-law 2016-131 is deleted in its entirety and replaced with the following:
 - 3.01 <u>Administration of the By-law:</u> The Director of Corporate Services and the Revenue and Procurement Manager are responsible for the administration of this by-law.
- 2.05 <u>Amendment to Appendix A Step 4</u>: Step 4 be amended to delete the reference to Corporate Services Manager, Revenue and Taxation/Deputy Treasurer certification and insert Director of Corporate Services and/or the Revenue and Procurement Manager's certification.
- 2.06 Amendment to Appendix B Definitions: Definitions within Appendix B be amended to delete the definition of Corporate Services Manager, Revenue and Taxation/Deputy Treasurer and insert a definition of Director of Corporate Services and Revenue and Procurement Manager as noted in Sections 2.02 and 2.03 of this By-law.

2.05 **Amendment to Appendix B – Signature Line**: The Signature Line is to be amended to delete the reference to Corporate Services Manager, Revenue and Taxation/Deputy Treasurer and insert Revenue and Procurement Manager certification and to remove specific name references.
