A By-Law to Amend the Township of Mariposa Zoning By-Law No. 94-07 to Rezone Land within the City of Kawartha Lakes

[File D06-17-009, Report PLAN2017-026, respecting Part Lot 5, Concession 9, being Part of Part 1, Plan 57R-733 and Part 2, Plan 57R-1197, identified as part of 71 CKL Road 46 - Grills]

Recitals:
