Background:

The purpose of the Parking By-law 2012-173 is to assist in the safe movement of traffic, ensure the safety of the public and to allow for the safe and efficient passage of emergency vehicles using our roadways.

Staff receive citizen requests to regulate roadways by adding prohibited parking areas. Staff collect these requests and circulate internally for comment to Public Works, Engineering and Planning.

This report addresses these citizen requests.

Rationale:

Municipal Law Enforcement Officers respond to approximately 240 parking complaints/concerns yearly and further staff receives nearly 20 requests yearly to amend the Parking by-law. The occurrences include concerns that driveways are being blocked; vehicles are parked facing the wrong direction and obstruction of the roadway.

Offences that violate the Parking by-law that do not require a by-law amendment or signs are as follows:

- Park a vehicle for longer than 12 hours;
- Park November 1st of one year to April 30th of the following year at any time between 11:00 p.m. and 6:00 a.m.;
- Park within 9m of an intersection;
- Park in front of or within 2.0 metres of an entrance or driveway;
- Park in a manner that obstructs or interferes with vehicular traffic
- Park in a manner that prevents the convenient movement or removal of another parked, standing or stopped vehicle; and
- Park facing the wrong direction.

Staff have collected the Prohibited Area citizen request data for a number of areas as summarized in the chart below. Should Council choose to adopt the recommendations as detailed below, By-Law 2012-173 being a By-Law to Regulate Parking attached as Appendix A will be amended to include the chart below.

Other Alternatives Considered:

No other alternatives have been considered.

Alignment to Strategic Priorities

Providing regulation that enhances the safe movement of traffic and protects the citizens using our roads, is a priority objective of the City under the Council Adopted Strategic Plan Goal of An Exceptional Quality of Life.

Financial/Operation Impacts:

Creating additional parking regulations may increase parking complaints to the Municipal Law Enforcement and Licensing Division and staff response times to other enforcement issues may be delayed, thereby increasing overall resolution times. These Parking by-law amendments are anticipated to have minimal impact on MLEL operations and will be absorbed within current working levels.

If Council resolves to move forward with the recommendations, Public Works staff will require time to adjust their work to arrange procurement, request locates and install the required signs. The cost for Public Works to purchase and install Prohibited Parking signs will be approximately \$300 per unit or \$12,900. Staff note that these are a common signs and some cost avoidance may occur if PW’s staff have stock that can be utilized prior to any additional sign purchase.
