We wish to make deputation to council to support our request to purchase the unopened road allowance adjacent to our property at 69 Rose Street, Pleasant Point.

Our Family cottage was built in the 1930's and has been in its current location for 90 years. My parents bought the property in the 1970's unaware that it encroaches on an unopened road allowance adjacent to the western property line.

We first inquired about the possibility of purchasing the road allowance in 2017 before we were aware of the encroachment and did not pursue the issue. A recent survey revealed the encroachment to us and we are now in the difficult position of not being able to obtain a building permit because of it. We realize our property will continue to deteriorate without repairs. The purchase of the road allowance is our preferred solution to this issue that will allow us to satisfy the city requirements for a building permit to restore and renovate our property.
