The Anglican Diocese of Toronto, property owner, and the church officers of the Anglican congregation of St. Luke's, Burnt River and I object in the strongest possible terms to the proposed heritage listing of our church as indicated in correspondence received from Emily Turner, Economic Development Officer-Heritage Planning, City of Kawartha Lakes. We are alarmed that this proposed Heritage Listing was initiated without previous consultation with us. Regardless of its stated purpose we object to the limitations such a heritage listing would place upon our control of the property we own.

The Anglican Churches in the municipality of Kawartha Lakes are multi-purpose buildings that collectively provide enormous community benefit in providing not only houses of worship and church ministry but also community food security programs, days cares, AA and other self help groups, art therapy, exercise groups and support programs for such things as Alzhiemers and dementia. We resist any external attempt that would result in any interference in the control and development of our properties that enable these enterprises to exist and flourish.
