Background

In the development and approval of the annual capital budget, the Terms of Reference of the Victoria Manor Committee of Management describe the Committee's role as follows:

Advice to Council

The Committee may make recommendations to Council on the following matters, for which Council retains the decision-making role:

1. the annual capital and operating budget;

In 2021 and previous years, the Ministry of Health and Long Term Care (MOHLTC) provided a Structural Compliance per diem to eligible long term care homes. For Victoria Manor, this funding was allocated to fund the annual capital budget. For the purposes of the proposed 2022 Capital Budget, \$113,604 will be allocated within the existing funding structure.

The requirements for capital projects in the home remain and are recommended to continue to maintain the home.

Rationale

The recommended 2022 capital projects, totaling \$150,000, are shown in Table 1 below.

While the potential for redevelopment may impact some future projects, the timing of a redevelopment decision and the immediate health and safety needs of residents and the home will be primary factors. It is not expected that Redevelopment, once approved, would be completed prior to 2023 or 2024.
