ORV route that was outlined in the ORV Task Force Meeting of 10.15.21.

At the 11.2.21 Committee of the Whole meeting, I wish to provide the Bobcaygeon survey results showing the community's response to ORVs being permitted on Bobcaygeon Streets. The survey was done through Survey Monkey, which also captured individual IP address information. The survey did not permit more than one response from an individual. Overall results and individual responses are available. The survey ran between 8.2.21 to 9.6.21 in order to capture both full and part time residents. The survey link was provided to a variety of groups and neighborhoods (via email and social media) in order to ensure that the survey was widely available within the population and to ensure an acceptable level of tolerance for accuracy of results. The survey produced a higher than normal response amongst the population indicative of a less than 5% margin of error and providing a 95+% confidence level as being representative of the overall population of Bobcaygeon,

The results:

The simple, 2 question survey asked if respondents were or were not in favour of permitting ORVs on Bobcaygeon Streets and also asked if they were residents of Bobcaygeon or not residents of Bobcaygeon but residents of the COKL.

As similarly noted with the Lindsay survey, the overall response was 53% not in favour and 47 % in favour of permitting ORVs on Bobcaygeon streets. Showing yet again that this is a highly debatable and divisive initiative.

However, when looking at the responses from Bobcaygeon only, the results show that Bobcaygeon is clearly not in favour of ORVs on Bobcaygeon Streets.

Bobcaygeon results - 309 respondents which represents roughly 12% of Bobcaygeon's over 18 population.

While 35% of respondents are in favour, 65% are NOT in Favour of ORVs on the Streets of Bobcaygeon.
