There was a complaint received by staff on May 25, 2021 of blowing litter, specifically balloons onto a neighboring property. The complaint was recorded and submitted to the MECP.

8. Other New Business

8.1 Biomonitoring Program Review

Kerri summarized a technical memo completed by Azimuth Environmental Inc. which reviewed 26 years of the biomonitoring reports and completed a statistical analysis on the results. Azimuth concluded that it is not necessary to continue the program. Community health metrics are generally stable. Clear downward trends

over the 25 years of monitoring in the number of invertebrates or health parameters were not found. Clear associations between community health parameters and bioaccumulation of contaminants were also not evident.

Staff will be submitting this technical memo to the Ministry of Environment, Conservation, and Parks (MECP). The MECP is aware that the City has completed this review of the program. Once the memo is submitted the District Officer will set up a meeting with the technical support experts at the MECP. The City will receive direction from the MECP at that time regarding the future of the program and whether an ECA amendment should be submitted.
