Good evening respected Councillors of the Kawartha Lakes;

For anyone who has not experienced the exhilaration and thrill of riding through the trails of the Kawartha's and enjoyed the nature and scenery, they would certainly not understand the social and mental benefits that these outings bring to individuals and their well-being.

My name is Greg Lawrence and I purchased a property in Cameron in November 2017 to use as a cottage for now, with the intention of eventually retiring there. I can honestly say that getting out on the trails and getting away from the hustle and bustle of Toronto is a welcome change and provides much needed stress relief while enjoying the sites and sounds of the outdoors.

More importantly, my 23 year old daughter lives at our cottage and is currently working 2 different jobs in Lindsay since graduating from the University of Guelph last year. She suffers from Anxiety, Depression and Social Anxiety disorder. She has been attending therapy since she was 12, and continues to see her regular therapist now, some 11 years later and although she has made significant progress, still experiences her depression.

One of the greatest therapeutic experiences she has, is going for a ride on our ATV, and a taking in the beauty and nature that the trails in the Kawartha's have to offer. To put aside the trials and tribulations of day to day challenges and clear her mind. We have hiked the trails, walked through Ken Reid Conservation Area and enjoyed all that nature can provide. In speaking with her therapist, I've been informed that this sole, and lone activity helps my daughter the most in overcoming and managing her illnesses. This is something that a trained professional cannot provide to a patient, and can also reap the greatest of rewards for those who need it the most.

While on a ride to the south towards Lindsay one day last year, she came across many butterflies and stopped to admire their beauty and activity. From there, she researched and learned of the declining population of the Monarch butterfly and the dangers that they face. She then contacted the Ministry of Natural Resources to see about obtaining a permit/license to 'breed' and re-populate the Monarch population and after several interviews and an

application process, she was awarded with a permit to do just that. This year alone, she was able to produce over 30 Butterflies from an egg, to a caterpillar, to chrysalids, to healthy Monarchs. I invite all of you to visit Rachel Lawrence on Facebook and witness these amazing pictures and videos that she has posted. Nature and the outdoors can significantly benefit an individuals mental health.

I am respectfully asking all councillors to consider the expansion of ATV trails through the Lindsay area for the enjoyment of the great outdoors for ATV and nature enthusiasts, and to also consider the positive affects this can have on those who suffer from mental illnesses. Our family time together on the trails is an important outing for all of us, and I have also invited many others from outside the Kawartha's to attend and support the local economy.
