Background:

At the Committee of the Whole meeting September 7, 2021, the following recommendation was made:

That Report ML2021-006, Discharge of Firearms by-law review and update, be received;

That the proposed By-Law, being a By-Law to Regulate the Discharge of Firearms in the City of Kawartha Lakes, attached as Appendix C to this report be approved;

That By-Law 2005 – 329 being a By-Law to Regulate the Discharge of Firearms in the City of Kawartha Lakes be repealed; and

That this recommendation be brought forward to Council for consideration at the next Regular Council Meeting.

That Report ML2021-006, Discharge of Firearms By-Law Review and Update, be received;

That the proposed By-Law, being a By-Law to Regulate the Discharge of Firearms in the City of Kawartha Lakes, attached as Appendix C to Report ML2021-006 be referred to staff for review and report back to incorporate the following amendments:

- that the definition of firearm in Section 1.01(i) be amended to replace the reference to 'weapon' with 'device'
- that Section 1.01(s) be deleted
- that Section 2.05 be deleted
- that Section 2.09 be amended to reduce the distance noted to 300 metres

- that Section 2.10 be amended to add 'unless the property owner's permission has been granted'
- that Section 4.01(f) be deleted
- that Section 7.03 be amended to confirm that the By-Law will be effective January 1, 2022

On November 16, 2021 at regular Council, staff presented, **Discharge of Firearms By-Law Review and Update**, supplemental to CR2021-049. The resolution was to deferred to December 14, 2021 Council meeting.

This report provides Council information and requests Council consider the proposed draft by-law.

Rationale:

Staff have reviewed **CR2021-419**, included the amendments recommended by Council and the proposed changes recommended by the Committee of the Whole in CW2021-213; the final draft of the amended by-law is attached as **Appendix A**, being a By-Law to Repeal and Replace By-Law 2005-329, being a By-Law to Regulate the Discharge of Firearms. The By-Law sections have been renumbered according to the amendments.

In addition to the amendments suggested in CR2021-419, staff is suggesting that the exemption offered in Section 4.01 (f) not be entirely deleted; instead, that it be amended by only removing "and a maximum of only ten (10) rounds being fired in a twenty four (24) hour period".

The amendment to section 4.01 (f) will read as follows:

Section 4.00: Exemptions

- 4.01 General Exemptions: The regulations established by this by-law do not apply to the activities and matters described below:
 - (f) For the Protection of Property from nuisance wildlife that may be killed or harassed in accordance with the Fish and Wildlife Conservation Act or a permit issued under the Canada Migratory Birds Regulations;

Leaving this exemption in the By-Law will provide property owners with options to protect their properties from nuisance wildlife as authorized by other regulation.
