To Whom it May Concern:

I am writing to you in regards to the road safety concerns at the corner of Glenelg St. and Cambridge St. This is the intersection King Albert is located on. It is a very high traffic intersection at multiple times throughout the day, but specifically at school entry and dismissal times. We have many safety practices we have had to put into place to ensure our students are safe at this time, including a crossing guard. Parking is extremely limited and there are no busses for students of King Albert, meaning they all either walk or get a ride to school. This creates a large volume of vehicles and people on the roads. The way the currency stop sign is located (east/west on Glenelg) does not allow for vehicles to have a clear line of sight to the south on Cambridge St. There have been many near-misses, as people either inch out to see clearly, or proceed at full speed unaware of on-coming traffic. In a school safety zone it is imperative that a 4 way stop be installed to protect the children and the community.
