#### Recommendation(s):

That Report PUR2022-012, Contract Administration Support and Inspection for Phase IV of the Downtown Reconstruction, be received;

**That** CIMA Canada Inc. be awarded the Contract Administration and Inspection for Phase IV of the Downtown Reconstruction in the amount of \$261,118.57 not including HST;

**That** \$63,137.00 in funding be transferred in the amount of \$31,568.50 from the Water Infrastructure Reserve (1.32050) and \$31,568.50 from the Sewer Infrastructure Reserve (1.32030), to cover the current deficit;

**That** \$100,000.00 in funding be transferred in the amount of \$50,000.00 from the Water Infrastructure Reserve (1.32050) and \$50,000.00 from the Sewer Infrastructure Reserve (1.32030), to cover the additional anticipated expenses relating to staff time;

**That** subject to the receipt of the required documents, the Mayor and Clerk be authorized to execute the agreements to award the contract; and

**That** the Procurement Division be authorized to issue a purchase order.

#### Background:

On September 21, 2021 Council approved Report Number CA2021-005 that identified capital projects for which early start is considered essential. Reconstruction of Downtown Lindsay, Phase 4 which includes York Street from Russell Street to Peel Street, William Street from Russell Street to Peel Street, and Peel Street from William Street to York Street.

PUR2017-049 approved Downtown Lindsay design work to be completed by CIMA Canada Inc. Road sections included in the design assignment are: Peel Street, Russell Street, Kent Street West, Cambridge Street, William Street, York Street and Lindsay Street South. During the design process CIMA Canada Inc. and staff conducted two (2) public meetings with local residents and businesses.

PUR2019-009 approved Phase 1 Contract Administration and Site Inspection to be awarded to CIMA Canada Inc.

ENG2020-004 approved Phase 2 Contract Administration and Site Inspection to be awarded to CIMA Canada Inc.

PUR2020-032 approved Phase 3 Contract Administration and Site Inspection to be awarded to CIMA Canada Inc.

Phase 4 construction was released and advertised in accordance with the Purchasing Policy, and was awarded to Coco Paving Inc. Construction is expected to commence in March 2022.

The Single Source purchase order number 909590 OS requested that CIMA provide support for the Contract Administration and Site Inspection for the Phase 4 Construction of Downtown Lindsay.

## **Rationale:**

CIMA has provided the Contract Administration and Inspection for all Phases of the Downtown Reconstruction thus far, therefore staff is recommending they be awarded Phase IV for the amount of \$261,118,57 not including HST.

## **Other Alternatives Considered:**

No other alternative is being considered as the Purchasing Management Directive allows for a single source to be permitted if the work required is of the same scope as a previously awarded procurement process.

# Financial/Operation Impacts:

Funds for the Contract Administration and Inspection Services for Phase IV of the Downtown Reconstruction was approved through the 2022 Capital Budget as per the table below:

Other committed funds include the construction, geotechnical services, and Contract Administration and Inspection Services.

It is recommended to fund the current deficit of \$63,137.00 with \$31,568.50 coming from the Water Infrastructure Reserve (1.32050) and \$31,568.50 coming from the Sewer Infrastructure Reserve (1.32030).

It is further anticipated that an additional \$100,000.00 will be required for staff time, in addition to the contract administration and inspection services. Therefore, it is recommended to fund the anticipated expenses with \$50,000.00 coming the Water Infrastructure Reserve (1.32050) and \$50,000.00 coming from the Sewer Infrastructure Reserve (1.32030).

After the application of the reserve amounts to fund expenditures in the above projects there will be \$7,973,782.00 remaining in the Sewer Infrastructure Reserve (1.32030) and \$6,162,458.00 in the Water Infrastructure Reserve. (1.32050).
