COKL Realty Services advised us that in the fall of 2001 COKL City Council resolved NOT to sell any Public Road Allowance that lead to water. Realty Services also advised us that any requests received by COKL to purchase Road Allowance leading water will be denied by the Land Management Committee.

This is also clearly outlined in the "Enquiries to Purchase Land FAQ" on COKL website. The Public Road Allowance access (PIN #631080267) to waters is the primary reason that we purchased this property as it added value to our property. However COKL has changed their position and has publicly advertised the sale of the Public Road Allowance leading to the water (<https://www.kawarthalakes.ca/en/news/proposed-surplus-declaration-closure-and-sale-shoreline-road-allowance-adj-29-fox-beach-lane.aspx>).

As part of the advertised sale, COKL Realty Services has also divided the Public Road Allowance only for the benefit of 2 owners as supposed to the benefit for the general public that enjoy the uses of Public Road Allowance.

If approved, this will significantly devalue our property and will impact our enjoyment of our property.
