#### **Background:**

At its meeting of October 7, 2021, the Committee discussed maintenance issues for heritage properties within the municipality and formed a subcommittee to begin taking photographs of all of the heritage properties within the municipality. The subcommittee decided it would like to start with City-owned buildings. The Chair of the Committee requested that a list of City owned heritage properties be provided by staff.

The following properties are owned by the City of Kawartha Lakes and are designated under Part IV of the Ontario Heritage Act:

- 103 Lindsay Street, Fenelon Falls (Fenelon Falls Railway Station)
- 50 Oak Street, Fenelon Falls (Maryboro Lodge)
- 5 Station Road, Kinmount (Kinmount Railway Station)
- 9 Cambridge Street North, Lindsay (Lindsay Fire Hall)
- 26 Francis Street, Lindsay (City Hall)
- 180 Kent Street West, Lindsay (Lindsay Town Hall)
- 190 Kent Street West, Lindsay (Lindsay Public Library)
- 210 Kent Street West, Lindsay (Lindsay Armoury)
- 50 Victoria Avenue North, Lindsay (Lindsay Old Gaol)
- 3448 Monck Road, Norland (Norland School)
- 1 King Street West, Omemee (Coronation Hall)
- 25 Pontypool Road, Pontypool (Pontypool Grain Elevator)
- 100A King Street, Woodville (Woodville Town Hall)
- 910 Hartley Road, Woodville (Palestine Community Hall)
