Request that Council instruct by-law office to investigate how to best protect the accessibility/vulnerability of Kawartha Lakes communities from Trap- Neuter- Return/Relocate cat organizations/groups of people who do not notify or alert the community of when these practices will be occurring, why or how these practices are occurring or ensuring the community they are certified/regulated.

The community of Pontypool is currently operating at rogue with miss informed information, inviting various out of region organizations to remove feral cats who administer questionable trap - neuter-relocate practices which can cause harm and lead to an unnecessary death of a feral or pet cats. Colony Caregivers are not included in these rogue community decisions which has divided this community. This chaos requires organization hence requires further investigation on what could be implemented in Kawartha Lakes to prevent further division of community and harm to cats.

My recommendations are for a unified approach that involves community consultation, scientific evidence based best practices, education/training, input from current Colony Caregivers and examples from other community's. This requires Council to instruct staff to further investigate options to amend the current By-Laws 2017-039.
