When we purchased 31 Pavillion Road which will be 5 years come this July 2022, we were assigned a spot on the lake and were informed that we had 5 year to build a deck.

Just some background, my husband is legally handicapped and requires a walker. When we visited the spot on the lake assigned to my home, we found it was quite far away and would be difficult for my husband to access.

I was informed that there was a spot just down from my house that was not assigned to anyone. I then contact the Township right away and asked if it would be possible to assign this spot close to my home in place of the one far away. I felt this was a reasonable request, due to my husband's disabilities. I would never make such a request if there was no spot vacant. I was told by the Township that this issue would not be considered at this time and to call in October or Spring. I have called every year since and told the same thing.

We did not want to build anything until this request was addressed as you can understand.

Now when I call again this year, I was informed that spots were all removed if nothing had been built on them.

During the last 4 years and my conversations with the Township, I was never informed that discussion of removing lake spots were a possibility. If I had know this we may have decided to proceed with building on our assigned spot, rather than losing it completely.

I hope you will take all of this into consideration and revisit our request to have the spot at the end of our street assigned to us, so my husband can finally enjoy walking down to the lake, which we have not been able to do since we moved it.
