An application for a Zoning By-law Amendment has been submitted by Tribute (Lindsay 2) Limited for land identified as 460 Thunder Bridge Road and described as Part of Lots 24 and 25, Concession 4, Geographic Township of Ops, Former Town of Lindsay, City of Kawartha Lakes. The application has been reviewed and it is considered to be a complete application in keeping with the prescribed regulations under the Planning Act.

The purpose of the application is to rezone a portion of the land in the Township of Ops Zoning By-law from the 'Future Community Development (FCD) Zone' to the 'Future Community Development Exception ** (FCD-**) Zone'.

The effect of the zoning change is to permit the temporary use of a portion of the property (approximately 0.7 hectares) for a home sales establishment with 5 model homes (6 units), and associated site specific development standards. The temporary use would be for a period of 3 years.

The land affected by the proposed Zoning By-law Amendment is shown on the Key Map as 'Subject Land'.

Our records indicate that the land subject of this application is cross-referenced with the original applications for Official Plan and Zoning By-law Amendments together with a Draft Plan of Subdivision application, File Numbers D01-2020-006, D06-2020-024 and D05-2020-001, and is also
