Fair Ave. in Lindsay (the one-block extension of Wellington St. that runs from Albert St. to Adelaide St.) has a high volume of traffic. The street is narrow (a metre narrower than Wellington), has no boulevard on the north side, and the houses were built close to the road. That volume of traffic--some of it travelling at speed--and the consequent noise, affect quality of life.

I have gathered names on a petition requesting that Fair Ave. be made one-way (with traffic travelling eastwards, from Adelaide to Albert). This has been done in the past--when the fall fair was on). Making Fair one-way would reduce the amount of traffic.

There are 46 names on the petition, 43 of them Fair Ave. residents. There are only 33 homes on Fair Ave., so this shows considerable support for the request.
