A By-law to Appoint Members to and Adopt Terms of Reference for the City of Kawartha Lakes Municipal Election Compliance Audit Committee

Recitals

- 1. Section 88.37 of the Municipal Elections Act, 1996. S.O. 1996 states, "A council or local board shall establish a compliance audit committee before October 1 of an election year for the purposes of this Act. 2016, c. 15, s. 66.c.32"
- Under the Municipal Election Act (MEA) "an elector who is entitled to vote in an election and believes on reasonable grounds that a candidate has contravened a provision of this Act relating to election campaign finances may apply for a compliance audit of the candidate's election campaign finances".
- At the July 19, 2022 Regular Council Meeting, Council passed resolution CR2022-253 approving Terms of Reference for the Compliance Audit Committee.
- 4. This by-law fulfills the legislative requirement to establish a compliance audit committee and formally adopts the Terms of Reference for the committee.

Accordingly, the Council of The Corporation of the City of Kawartha Lakes enacts this By-law 2022-___.

Section 1.00: Definitions and Interpretation

1.01 **Definitions**: In this by-law,

"City", "City of Kawartha Lakes" or "Kawartha Lakes" means The Corporation of the City of Kawartha Lakes and includes its entire geographic area;

"City Clerk" means the person appointed by Council to carry out the duties of the clerk described in section 228 of the Municipal Act, 2001;

"Council" or "City Council" means the municipal council for the City;

1.02 Interpretation Rules:

- (a) The Schedules attached to this by-law form part of the by-law, and are enforceable as such.
- (b) The words "include" and "including" are not to be read as limiting the meaning of a word or term to the phrases or descriptions that follow.
- 1.03 **Statutes:** References to laws in this by-law are meant to refer to the statutes, as amended from time to time, that are applicable within the Province of Ontario.

1.04	Severability: If a court or tribunal of competent jurisdiction declares any
	portion of this by-law to be illegal or unenforceable, that portion of this by-
	law shall be considered to be severed from the balance of the by-law,
	which shall continue to operate in full force and effect.
