3.1 KLMHC2022-062

Objection to the Listing of Property – 12 Helen Street, Fenelon Falls

The Committee discussed the request from the property owner of 12 Helen Street to remove it from the Register. A. Hart and I. McKechnie suggested that the property should remain on the Register due to its uniqueness in Fenelon Falls. W. Peel felt that the property should be removed from the Register as this was the owner's wish and that the property owner may wish to redevelop the area. E. Turner confirmed she did not know the owner's intent with regard to the property. S. Sims suggested that the property owner be asked to provide additional information regarding their reason for objection.
