**That** Report CS2022-013, Bobcaygeon Legacy C.H.E.S.T. Fund 2022 allocation, be received;

**That** total funding in the amount of \$63,930.37 be provided, with the allocation to come from the Bobcaygeon Legacy C.H.E.S.T. Fund Reserve (3.24320), for the projects as recommended by the Bobcaygeon Legacy C.H.E.S.T. Fund Grant Committee at its November 2, 2022, as follows:

**That** \$4,617.57 (10% of interest earned from September 30, 2021 to August 31, 2022) be retained in the principle of the Bobcaygeon Legacy C.H.E.S.T. Fund Reserve (3.24320) for inflationary growth of the fund;

**That** the remaining \$41,722.63 of available funds not allocated in 2023 be available for distribution in a future year.

### **Background:**

On November 2, 2021, The Bobcaygeon Legacy C.H.E.S.T. Fund Grant Committee met to review and recommend applications for the disbursement of 2023 funding.

Eight (8) applications were received via email to Committee Secretary LeAnn Donnelly prior to the posted deadline and one (1) application was received after the posted deadline. All applications were circulated to Committee members.

The recommendations drawn from the minutes of the meeting form the basis for the findings of this report.

#### **Rationale:**

Total interest earned from September 30, 2021 to August 31, 2022 is \$46,175.68. The Committee remains committed to the retention of earnings for inflationary growth fund therefore (10%) \$4,617.57 of interested earned from September 30, 2021 to August 31, 2022 will be allocated directly to the principal of the fund. There is a balance of \$68,922.26 of unallocated funds from previous years minus 4,827.37 from a return of 2010 accrual contingency for Hydro One Dispute. This results in a total of \$105,653.00 being available for distribution.

There were nine (9) applications submitted, however one was received after the deadline therefore not considered for funding in 2023. The eight (8) eligible applications resulted in a total request of \$63,930.37. All applications have been reviewed by the committee, and as a result all one (1) applications is recommended to receive full funding and seven (7) applications are recommended to receive partial funding.
