# **Background:**

City staff annually conduct a review of this By-law that establishes the requirement for payment of fees for Information, Services, Activities and Use of City Property in The City of Kawartha Lakes.

As provided in Section 2.06 of this By-Law, staff annually update the Consolidated Fees By-law using consumer price index (CPI) estimates provided by Statistics Canada for Ontario.

#### Rationale:

The analysis of the 2022 data indicates that the Ontario CPI increased sharply to rates not seen in the past 40 years, as high as 8.8%. These increases are a result from ongoing supply chain disturbances and an increased price for services.

Historic high inflation rates have made it financially challenging for residents, particularly those with low or fixed incomes. While the increased inflation reflects global developments that are uncontrollable, in general, it reflects what's happening in our own community. The demand for goods and services are running ahead of the economy's ability to supply them. Businesses are having a hard time finding enough workers. What started as higher prices and delays for many internationally produced goods has now broadened to many services. In consideration of these challenging financial times to our residents, it is prudent and recommended that the increase in fees for 2023 be tied to the City's 2023 proposed operating budget increase, which is 3%, as opposed to applying the CPI equivalent.

#### **Other Alternatives Considered:**

Council could choose to apply the by-law required 8.8% CPI increase to the standard fees, however, given the undesirable financial impact to residents, this is not recommended.

### **Alignment to Strategic Priorities**

This report aligns with the Kawartha Lakes 2020-2023 Strategic Plan priority of Good Government.

#### **Financial/Operation Impacts:**

The 2023 estimate for user fee revenue is \$27.9 million. The impact of applying a 3% increase in the affected fees rather than the CPI increase of 8.8%, results in an estimated \$400,000 loss in revenue.

#### **Consultations:**

Senior Management/their respective divisions provided direction on fees increases.
